



## WOOL MARKET REPORT – 3 FEBRUARY 2016

On the 21<sup>st</sup> wool auction of the 2015/2016 season, the Cape Wools merino wool market indicator decreased by -1.3% to close on 15686c per kg clean. This is approximately 44.50% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstile strength of 35 (NKT) were as follows:

18 µ	17535 (+1.1%)	21 µ	15599 (-1.0%)
19 µ	16563 (+0.4%)	22 µ	14793 (-1.6%)
20 µ	15632 (-1.5%)	23 µ	14638 (-1.2%)

The main buyers on the sale were: Lempriere South Africa (2,651 bales), G Modiano (2,186 bales) Standard Wool (1,828 bales). Of the 8,390 bales offered 8,244 bales were declared sold (98%).
