



## WOOL MARKET REPORT – 10 FEBRUARY 2016

On the 22<sup>nd</sup> wool auction of the 2015/2016 season, the Cape Wools merino wool market indicator decreased by -0.9% to close on 15540c per kg clean. This is approximately 41.75% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

19 μ	16273 (-1.8%)	22 μ	14906 (+0.8%)
20 μ	15506 (-0.8%)	23 μ	14609 (-0.2%)

The main buyers on the sale were: Lempriere South Africa (2,015 bales), Standard Wool (1,850 bales) G Modiano (703 bales). Of the 5,950 bales offered 5,841 bales were declared sold (98%).
