MARKET COMMENTARY

MOHAIR REASONABLY STEADY

On the third auction of the summer season, the offering consisted of good quality mohair. The market indicator closed slightly lower on R253.28 reflecting a decline of 2%. The Rand strengthened by 0.44% against the American Dollar and is currently trading at R15-86.

The demand for strong adult mohair remained unchanged whilst prices of fine adult mohair declined by 3% to close on R262.33.

The demand for young goat hair was unchanged on R289.18.

Summer kid mohair ended on R325.15, a decline of 4%.

The largest buyer in the day was Stucken.
