MARKET COMMENTARY

STRONGER RAND PLACES PRESSURE ON PRICE LEVELS

On the 4th auction of the summer season, despite good competition, the stronger Rand negatively influenced prices of mohair. Adult mohair prices were the most adversely affected. The Rand is currently trading 7.4% stronger against the American Dollar at R14-68. The average market indicator declined by 5% to close on R240.15. The stronger Rand had the greatest impact on strong adult mohair and prices closed 5% lower on R235-97, whilst prices of fine adult mohair ended 2% lower on R257-46. Prices of young goat hair were in buyers' favour and closed 1% lower on R286-20. Prices of kid mohair closed 4% lower on R310-64. The largest buyer on the day was Samil.
