



## WOOL MARKET REPORT – 26 OCTOBER 2016

On the 10<sup>th</sup> wool auction of the 2016/2017 season, the Cape Wools merino wool market indicator decreased by -0,9% to close on 15220c per kg clean. This is approximately 23.51% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

18 µ	16890 (+0,7%)	21 µ	14527 (-2,5%)
19 µ	16440 (+0,6%)	22 µ	14367 (-1,2%)
20 µ	15196 (-0,9%)	23 µ	13705 (-0,7%)

The main buyers on the sale were: G Modiano (2,887 bales), Standard Wool (2,597 bales), Lempriere South Africa (2,417 bales). Of the 9,676 bales offered 9,588 bales were declared sold (99%).
