



WOOL MARKET REPORT – 28 MARCH 2018

On the 27th wool auction of the 2017/2018 season, the merino wool market indicator decreased with -2,5% to close on 17264c per kg clean. This is approximately 5,91% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

The main buyers on the sale were: G Modiano (4,501 bales), Standard Wool (3,434 bales), Tianyu S A Pty (Ltd) (1,805 bales). Of the 12,267 bales offered 12,023 bales were declared sold (98%).
