



## WOOL MARKET REPORT – 9 MAY 2018

On the 31<sup>st</sup> wool auction of the 2017/2018 season, the merino wool market indicator increased with +0,6% to close on 19070c per kg clean. This is approximately 19,61% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

18 µ	22477 (-1,2%)	21 µ	18942 (unchanged)
19 µ	19987 (+0,6%)	22 µ	18605 (+2,7%)
20 µ	19183 (+0,5%)	23 µ	16047 (+0,7%)

The main buyers on the sale were: Standard Wool (2,123 bales), G Modiano (2,053 bales), Tianyu S A Pty Ltd (1,303 bales). Of the 7,340 bales offered 7,310 bales were declared sold (99%).
