



## WOOL MARKET REPORT – 23 MAY 2018

On the 32<sup>st</sup> wool auction of the 2017/2018 season, the merino wool market indicator increased with +5,6% to close on 20136c per kg clean. This is approximately 24,01% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

The main buyers on the sale were: Standard Wool (3,241 bales), Tianyu S A Pty Ltd (1,826 bales), G Modiano (1,162 bales) . Of the 9,288 bales offered 9,251 bales were declared sold (99%).
