



## WOOL MARKET REPORT – 30 MAY 2018

On the 33<sup>rd</sup> wool auction of the 2017/2018 season, the merino wool market indicator increased with +2,9% to close on 20723c per kg clean. This is approximately 30,69% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

18 µ	24147 (+1,7%)	21 µ	20760 (+3,1%)
19 µ	21524 (+2,9%)	22 µ	20235 (+2,7%)
20 µ	20957 (+3,1%)	23 µ	17417 (+2,8%)

The main buyers on the sale were: Standard Wool (1,712 bales), G Modiano (1,383 bales), Lempriere S A (634 bales). Of the 4,923 bales offered 4,891 bales were declared sold (99%).
