



## WOOL MARKET REPORT – 15 AUGUST 2018

On the 1<sup>st</sup> wool auction of the 2018/2019 season, the merino wool market indicator increased with +12,4% to close on 23829c per kg clean..

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

18 µ	27235	(+13,1%)	21 µ	24168	(+12,8%)
19 µ	25074	(+12,2%)	22 µ	23751	(+15,5%)
20 µ	24656	(+14,9%)	23 µ	20098	(+12,9%)

The main buyers on the sale were: Standard Wool (3,597 bales), G Modiano (3,518 bales), Lempriere S A (1,348 bales). Of the 11,140 bales offered 11,089 bales were declared sold (99%).
