



WOOL MARKET REPORT – 19 SEPTEMBER 2018

On the 5th wool auction of the 2018/2019 season, the merino wool market indicator decreased with -4,3% to close on 24290c per kg clean. This is approximately 37,02% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

The main buyers on the sale were: Standard Wool (2,520 bales), G Modiano (2,482 bales), Tianyu S A Pty (Ltd) (2,132 bales). Of the 11,061 bales offered 11,021 bales were declared sold (99%).
