



WOOL MARKET REPORT – 10 OCTOBER 2018

On the 8th wool auction of the 2018/2019 season, the merino wool market indicator increased with +3,7% to close on 23216c per kg clean. This is approximately 27,71% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:
