



## WOOL MARKET REPORT – 17 OCTOBER 2018

On the 9<sup>th</sup> wool auction of the 2018/2019 season, the merino wool market indicator decreased with -3,8% to close on 22324c per kg clean. This is approximately 24,58% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

The main buyers on the sale were: G Modiano (2,743 bales), Standard Wool (1,707 bales), Tianyu S A Pty (Ltd) (1,703 bales) .Of the 7,988 bales offered 7,668 bales were declared sold (95%).
