



WOOL MARKET REPORT – 7 NOVEMBER 2018

On the 12th wool auction of the 2018/2019 season, the merino wool market indicator decreased with -6,0% to close on 20468c per kg clean. This is approximately 4,99% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

The main buyers on the sale were: G Modiano (2,648 bales), Tianyu S A Pty (Ltd) (2,251 bales), Standard Wool (2,055 bales) .Of the 9,189 bales offered 8,630 bales were declared sold (93%).
