



## WOOL MARKET REPORT – 14 NOVEMBER 2018

On the 13<sup>th</sup> wool auction of the 2018/2019 season, the merino wool market indicator increased with 0,7% to close on 20614c per kg clean. This is approximately 4,41% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

The main buyers on the sale were: G Modiano (3,977 bales), Standard Wool (3,030 bales), Tianyu S A Pty Ltd (1,828 bales). Of the 912,226 bales offered 11,716 bales were declared sold (95%).
