



WOOL MARKET REPORT – 21 NOVEMBER 2018

On the 14th wool auction of the 2018/2019 season, the merino wool market indicator increased with 1,9% to close on 21012c per kg clean. This is approximately 9,24% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

The main buyers on the sale were: Standard Wool (2,736 bales), G Modiano (2,502 bales), Tianyu S A Pty Ltd (1,374 bales). Of the 9,350 bales offered 9,233 bales were declared sold (98%).
