



WOOL MARKET REPORT – 28 NOVEMBER 2018

On the 15th wool auction of the 2018/2019 season, the merino wool market indicator decreased with -1,1% to close on 20771c per kg clean. This is approximately 11,34% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

The main buyers on the sale were: G Modiano (3,971 bales), Standard Wool (3,322 bales), Tianyu S A Pty Ltd (1,979 bales). Of the 12,939 bales offered 12,504 bales were declared sold (96%).
