



WOOL MARKET REPORT – 5 DECEMBER 2018

On the 16th wool auction of the 2018/2019 season, the merino wool market indicator increased with 0,1% to close on 20785c per kg clean. This is approximately 10,76% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

The main buyers on the sale were: G Modiano (4,194 bales), Standard Wool (3,117 bales), Lempiere S A (1,840 bales). Of the 12,247 bales offered 12,015 bales were declared sold (98%).
