



## WOOL MARKET REPORT – 9 JANUARY 2019

On the 17<sup>th</sup> wool auction of the 2018/2019 season, the merino wool market indicator increased with 4,2% to close on 21648c per kg clean. This is approximately 15,10% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

18 µ	24033 (+2,3%)	21 µ	22453 (+3,3%)
19 µ	23098 (+3,6%)	22 µ	21383 (+4,3%)
20 µ	22758 (-3,2%)	23 µ	17709 (+3,5%)

The main buyers on the sale were: Standard Wool (3,476 bales), G. Modiano (3,471 bales), Lempiere S A (1,693 bales) .Of the 10,675 bales offered 10,431 bales were declared sold (97%).
