



## WOOL MARKET REPORT – 23 JANUARY 2019

On the 19<sup>th</sup> wool auction of the 2018/2019 season, the merino wool market indicator increased with + 2,7% to close on 22102c per kg clean. This is approximately 19,11% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

18 µ	24615 (+1,3%)	21 µ	22747 (+1,7%)
19 µ	23913 (+2,3%)	22 µ	21579 (+2,3%)
20 µ	23160 (+2,0%)	23 µ	18061 (+2,0%)

The main buyers on the sale were: Standard Wool (2,655 bales), G Modiano (2,228 bales), Lempiere S A (1,620 bales) .Of the 8,979 bales offered 8,750 bales were declared sold (97%).
