



## WOOL MARKET REPORT – 26 FEBRUARY 2019

On the 23<sup>rd</sup> wool auction of the 2018/2019 season, the merino wool market indicator decreased with -0,3% to close on 21876c per kg clean. This is approximately 17,96% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

The main buyers on the sale were: G Modiano (1,387 bales), Tianyu South Africa Pty (Ltd) (1,127 bales), Standard Wool (1,055 bales). Of the 5,924 bales offered 5,207 bales were declared sold (87%).
