



WOOL MARKET REPORT – 27 FEBRUARY 2019

On the 24th wool auction of the 2018/2019 season, the merino wool market indicator decreased with -0,3% to close on 21760c per kg clean. This is approximately 17,24% higher than a year ago.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

The main buyers on the sale were: G Modiano (1,951 bales), Standard Wool (1,330 bales), Lempriere South Africa (767 bales). Of the 6,165 bales offered 5,533 bales were declared sold (89%).
