



WOOL MARKET REPORT – 20 MARCH 2019

On the 27th wool auction of the 2018/2019 season, the merino wool market indicator increased with +0,9% to close on 21642c per kg clean.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

The main buyers on the sale were: Tianyu S A Pty (Ltd) (1,492 bales), G Modiano (1,465 bales), Standard Wool (914 bales) .Of the 5,514 bales offered 4,880 bales were declared sold (88%).
