



WOOL MARKET REPORT – 3 APRIL 2019

On the 28th wool auction of the 2018/2019 season, the merino wool market indicator decreased with -4,9% to close on 20584c per kg clean.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:

The main buyers on the sale were: Standard Wool (3,347 bales), G Modiano (1,993 bales), Tianyu S A Pty (Ltd) (1,737 bales). Of the 11,478 bales offered 9,263 bales were declared sold (80%).
