



WOOL MARKET REPORT – 5 June 2019

On the 34th wool auction of the 2018/2019 season, the merino wool market indicator increased with 0,04% to close on 20607c per kg clean.

Average clean wool price indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:
