### MARKET COMMENTARY

#### ADULT MOHAIR PRICES DISAPPOINTING

On the opening auction of the winter season, the sales of especially strong adult mohair were very disappointing. The rand strengthened by 10,5% against the American Dollar and is currently trading at R13-30. The average market indicator declined by 3% by comparison with the corresponding auction a year ago and closed on R178-63. By comparison with the last summer auction, however, the market indicator closed 24,4% lower. By contrast with the corresponding auction a year ago, the prices of strong adult mohair declined 11% to R162-69 and those of fine adult mohair were 3% cheaper at R185-54. Compared to the last auction of the summer season, the prices of strong adult mohair, however, declined by 28,3% and those of fine adult mohair by 26,1%. By comparison, the prices of fine young goat hair increased by 8% to close on R229.00. By comparison with a year ago, the prices of kid mohair closed 12% dearer on R276-49. The largest buyer on the day was Stucken.
