### KOMMENTAAR

Kompetisie tussen die kopershuise was weereens goed. Kids was gemiddeld 3.6% goedkoper en Jong bokke het gemiddeld teen dieselfde vlakke verhandel as op die vorige veiling. Fyn groot bokke het die beste verbetering getoon en was gemiddeld 3.8% duurder. Sterk groot bokke het ook 2.0% duurder verkoop as op die vorige veiling. Die gemiddelde markaanwyser verhandel teen R224.00/kg, 1% hoër.

### COMMENTS

Competition between the different buying houses were good once again. Kids on average was 3.6% cheaper and the Young goats traded on the same levels as on the previous auction. Fine adults showed the most improvement and sold on average 3.8% higher. Strong adult mohair was also 2.0% higher than the previous auction. The average market indicator traded at R224.00/kg, 1% higher.
