MARKET COMMENTARY SUMMER SEASON OPENS WELL

The sale of mohair on the opening auction of the summer season was outstanding and good prices were achieved. With the mixed offering, typical of the first auction of the season, it is difficult to draw comparisons. The increase in prices can be attributed in the main to the weaker Rand.

The Rand weakened by 9,3% against the American Dollar and is currently trading at R15-75.

The demand for especially stronger types of mohair was outstanding and the prices of strong adult mohair increased by 15% to end on R245-29 whilst the prices of fine adult mohair were 13% dearer on R259-27.

The good demand for young goat hair has continued and prices increased by 6,5% to R274-70.

The demand for the limited quantity winter kid mohair was good with prices 7,5% dearer on R308-66. Summer kid mohair quotes was not available as the offering was too small.

The largest buyer on the day was Samil.
