**MARKET COMMENTARY
MOHAIR MARKET STEADY**

On the second auction of the summer season, the market was steady and the general market indicator increased by 1,7% to close on R258-59. The Rand increased by 0,25% against the American Dollar and is currently trading at R15-79. The demand for strong adult mohair was unchanged and prices of fine adult mohair rose by 4% to close on R269-85. The demand for young goat hair increased by 3% to end on R292-42.

Although the summer kid mohair was slightly cheaper, winter kid mohair was more expensive which left the kid mohair segment unchanged.

Summer kid mohair ended on R338-20 and winter kid mohair on R322-21.
