## BOKHAAR VEILINGSVERSLAG / MOHAIR MARKET REPORT W07-2019

03/12/2019

### KOMMENTAAR

Die laaste veiling van die jaar was vandag aangebied en die sterker mikron bokhaar het weereens 'n daling in prys getoon. Kids was gemiddeld 2.0% duurder en Jong bokke 1.0% duurder in vergelyking met die vorige veiling. Fyn groot bokke se prys het teuggesak en was gemiddeld 2.6% goedkoper. Sterk groot bokke het die meeste daling getoon en 3.3% goedkoper verkoop as op die vorige veiling. Die gemiddelde markaanwyser was 2.2% laer en het gesluit op R218.97/kg.

### COMMENTS

The last auction for the year took place today with the stronger micron mohair yet again under pressure. Kids on average were 2.0% higher with the Young goats at 1.0% higher than on the previous auction. Fine Adults showed a decrease in price and sold on average for 2.6% lower than the previous auction. Strong Adult mohair was discounted the most and sold on average at 3.3% cheaper than on the previous auction. The average market indicator trade 2.2% lower at R218.97/kg.
