BOKHAAR VEILINGSVERSLAG / MOHAIR MARKET REPORT B10-2020

KOMMENTAAR

Vandag se veiling was onder baie druk agv al die onsekerheid wat tans heers, nie net in ons ekonomie nie, maar die wêreld ekonomie. Die aanvraag was swakker van beide China en Euproa agv die Corona pandemie. Kids was gemiddeld 5.7% goedkoper en Jong bokke 5.0% in vergelyking met die vorige veiling. Fyn groot bokke het die meeste teruggesak en was gemiddeld 6.8% goedkoper. Sterk groot bokke het ook die dalende mark gevolg en was gemiddeld 4.6% goedkoper as op die vorige veiling. Die gemiddelde markaanwyser was 7.0% laer en het gesluit op R267.27/kg.

COMMENTS

Today's auction was under severe pressure because of the uncertainty in both our and the world economy. The demand from both China and Europe were considerably less than 2 weeks ago because of the Corona pandemic. Kids on average were 5.7% and Young goats 5.0% cheaper than on the previous auction. Fine Adults decreased the most and was on average 6.8% cheaper. Strong Adult mohair also followed the falling market and was 4.6% cheaper than on the previous auction. The average market indicator traded 7.0% lower at R267.27/kg.
