KOMMENTAAR

Die skeersels op vandag se veiling was weereens van uitstaande kwaliteit en BKB spog met die hoogste prys vir die dag. Baie geluk aan Mnr Daan Schutte van Willowmore, sy baal BSFFK (24.4 mik) het verkoop vir R562.10. Europese verwerkers is nogsteeds nie 100% operasioneel nie en dit het die mark effens afwaarts laat neig. Fyn Kids en fyn jongbokke het baie goed verhandel en die gemiddelde prys was onveranderd. Fyn grootbokke het die meeste teruggesak en was gemiddeld 3.0% goedkoper. Sterker haar het weereens onveranderd verhandel. Die gemiddelde markaanwyser het 1,0% laer verhandel teen R225.60/kg.

COMMENTS

The clips on today's sale were once again of the highest quality and BKB can boast with the highest price of the day. Congratulations to Mr Daan Schutte from Willowmore, his bale BSFFK (24.4 mic) which sold for R562.10. European mills are still not operating on 100% of capacity and this pushed the market down slightly. Fine Kids and young goats performed very well, and the average price was unchanged. Fine Adults came back the most and was on average 3.0% cheaper. Stronger adult mohair traded on the same levels as on the previous auction. The average market indicator traded 1.0% lower at R225.60/kg.
